FOR THREE (03) PUBLIC-PRIVATE PARTNERSHIP PROJECTS



The Assignment

The Finance Department, Government of Sindh, invites proposals from reputable and experienced consulting firm(s)/consortium(s) to conduct Environmental Impact Assessment (EIA) and Land Acquisition and Resettlement Plan (LARP) Studies for the following three (03) mega projects which are being developed under public-private partnership mode: **i) Ghotki Kandhkot Bridge Project; ii) Malir Expressway Project; and iii) M9-N5 Link Road Project.**

Objectives of the Assignment

The Government of Sindh intends to engage the services of a qualified consulting firm(s) / consortium(s) for conducting (i) EIA studies for each of the three (03) projects that meet both the requirements of Sindh Environmental Protection Agency (SEPA) and the ADB's Safeguard Policy Statement 2009 (SPS) and (ii) LARP studies for each of the three (03) projects by conducting screening and detailed assessment of Involuntary Resettlement (IR) impacts (including the encroachers/squatters and other un-titled persons who may be displaced physically or economically) of the projects and preparation of LARPs, as may be required. Keeping in mind the complexity of these three (03) projects, the selected firm will need to engage a complete team of experts with considerable experience in conducting EIA and LARP studies for projects of such scale.

The detailed Scope of Work and the Terms of Reference for each project are illustrated in the Request for Proposals document.

Basic Eligibility: Registration with the relevant tax authority(ies); and Registration with Pakistan Engineering Council, as further detailed in the Request for Proposals (RFP).

Bidding Process: Single Stage Two Envelope – technical and financial proposals in separate sealed envelopes, as detailed in the RFP.

Bid Security: Two (2%) percent of the quoted bid price.

Pre-Bid Meeting: 17th March, 2020 at 11 a.m. in the Committee Room of the PPP Unit, Finance Department (address given below).

Last Date for Queries: 20th March, 2020.

Bids Submission Deadline: 27th March, 2020 at 11:00 a.m.
